

Eaglecrest High School Student Contract Adventure Waiver

ACKNOWLEDGMENT OF RISK:

I hereby acknowledge and agree that adventure activities such as climbing walls, rock climbing, rappelling, backpacking, camping, challenge courses, and other adventure activities have inherent risks. Adventure education programs are, by definition, fraught with risks. A prudent program does all it can to deal in perceived risks and to reduce but not eliminate the real risks by the use of accepted safety procedures.

PARTICIPATION IN ADVENTURE PROGRAMS:

I accept the fact that the program instructors cannot guarantee my total safety since some risks in adventure education are beyond their control. I agree to follow all instructions and guidelines given by them, and to act in a safe and responsible manner toward all participants and the environment.

I fully comprehend and willingly assume the responsibilities and risks of participating in this program, as outlined in the orientation information and as explained to me by the instructor(s).

WAIVER OF RIGHT TO SUE:

By signing below, I agree to fully absolve the Eaglecrest High School class called Adventure Education, and its employees or volunteers from all liability for any damages, injuries or losses which might be sustained while participating in this program.

MEDICAL INFORMATION:

I am sufficiently fit to participate in this program. I have a medical form on file in the nurses' office with health disclosure information that is accurate, complete and true to the best of my knowledge. I agree to notify the program instructors of any changes to my health and fitness which may occur before or during the class. Should I become ill or injured, I give permission for the program instructors to render first aid and to seek emergency medical or rescue services, as they see fit and at my cost.
